Simplex Infra announces Q2FY17 results

Kolkata, December 3, 2016 – Simplex Infra has announced its unaudited Results for the Second Quarter and the Half Year ended Sept'16 in accordance with Companies (Indian Accounting Standards) Rules, 2015 (Ind AS).

During the quarter the Company registered standalone topline of ₹ 1290 cr against ₹ 1464 cr for the same quarter last year. Its EBITDA for the Quarter stands at ₹ 160 cr (₹ 166 cr), EBIT ₹ 110 cr (₹ 115 cr), PBT ₹ 29 cr (₹ 40 cr) and PAT at ₹ 18 cr (₹ 26 cr).

For the first half of FY17, the Company clocked standalone sales of ₹ 2732 cr against ₹ 3013 cr for the same period last year. Its EBITDA for the half year stands at ₹ 324 cr (₹ 336 cr), EBIT ₹ 224 cr (₹ 234 cr), PBT ₹ 57 cr (₹ 81 cr) and PAT at ₹ 35 cr (₹ 51 cr).

The Order-book as on 30th Sept'16 stands at ₹ 13485 crs excluding the L1 of ₹ 2543 crs. The new order intake during the quarter was ₹ 978 crs and for the first half ₹ 2123 crs.
