Certified True Copy of the Extract of the Minutes of the Meeting of the Board of the Directors of Simplex Infrastructures Limited held on Tuesday, 25<sup>th</sup> April, 2023 through Video Conferencing (VC)/ Other Audio-Visual Means(OAVM)

Review of the request received from the promoters of the Company for removal/ re-classification from 'Promoter and Promoter Group' category of the Company

The Chairman informed the Board that Mr. Bithal Das Mundhra, Mrs. Yamuna Mundhra, Mr. Amitabh Das Mundhra, Mrs. Savita Mundhra, Mrs. Anuja Mundhra and Mrs. Savita Bagri ("Outgoing Promoters"), belonging to 'Promoter and Promoter Group' of the Company, have requested the Company for re-classification/ removal of their name from 'Promoter and Promoter Group' category of the Company vide their letters dated 24th April, 2023. The Letters received from the Outgoing Promoters were placed before the Board for its perusal.

The Board was informed of the rationale for such re-classification/removal that the 'Outgoing Promoters' do not hold any equity shares of the Company as on date and therefore do not have any voting rights in the Company but still have their name under Promoter/Promoter Group Category in the shareholding pattern filed by the Company with the stock exchanges. Moreover, they are not engaged in the management or day to day affairs of the Company or involved in management or policy decisions of the Company in any manner and also do not have any right either to appoint any Director of the Company and none of their act would influence the decision taken by the Company.

Further the Board was also apprised that 'Outgoing Promoters' have confirmed that they are satisfying all the conditions specified in sub clause (i) to (vii) of clause (b) of sub-regulation 3 of Regulation 31 A of Listing Regulations and that the said reclassification shall require the approval of the Board, shareholders/ members of the Company and the stock exchanges where the shares of the Company are listed namely, BSE Limited, National Stock Exchange of India Limited and CSE Limited ("Stock Exchanges").

Accordingly on the basis of the rationale and in accordance with provisions of Regulation 31 A of SEBI Listing Regulations, the Board was of the view that the above mentioned requests for re-classification/removal of name be accepted and approved by the Board of Directors of the Company, which shall be subject to the approval of the Members of the Company and the Stock Exchanges and/or such other approval, if any, as may be necessary in this regard.



The Board considered the matter and passed the following resolution:

"RESOLVED THAT pursuant to the provisions of Regulations 31 A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, ("Listing Regulations") and subject to the approvals of the Shareholders and approvals of the Stock Exchanges, where the equity shares of the Company are listed and/or such other approval, if any, as may be required in this regard, the approval of the Board of Directors be and is hereby accorded to the respective requests received from Mr. Bithal Das Mundhra, Mrs. Yamuna Mundhra, Mr. Amitabh Das Mundhra, Mrs. Savita Mundhra, Mrs. Anuja Mundhra and Mrs. Savita Bagri ("Outgoing Promoters"), for removal/re-classification of their name from "Promoter and Promoters Group" category of the Company."

"RESOLVED FURTHER THAT approval be and is hereby given to the Company to seek shareholders' approval in relation to the re-classification in accordance with Regulation 31A of the Listing Regulations and the Company is hereby authorized to take all necessary steps in this regard."

RESOLVED FURTHER THAT for the purpose of giving effect to the foregoing resolution, Mr. S. Dutta, Whole-time Director & CFO, and Mr. B.L. Bajoria, Sr.V.P. & Company Secretary be and are hereby severally authorized on behalf of the Company to do, either by themselves or through delegation to any person, as they may in their absolute discretion deem fit, all such acts, deeds, matters and things as they may at their discretion deem necessary or expedient for such purpose, and make all necessary filings including but not limited to making applications to the stock exchanges to seek their approval for the re-classification in accordance with Listing Regulations and other applicable laws, if any, and to execute all such deeds, documents or writings as are necessary or expedient, to settle any questions, difficulties or doubt that may arise in this behalf."
