Kolkata, February 14, 2018 – Simplex Infra has announced its Standalone Unaudited Financial Results for the 3^{rd} Quarter and Nine Months ended Dec'17.

During the quarter the Company achieved income from operations of ₹ 1360 cr as against ₹ 1386 cr same quarter last year. Its EBITDA rose by 3% to ₹ 200 crs (₹ 194 crs) , EBIT by 7% to ₹ 155 cr (₹ 145 cr), PBT by 42% to ₹ 40 cr (₹ 28 cr) and PAT by 69% to ₹ 31 cr (₹ 18 cr)

During the Nine months of FY18, the Company's income from operations is ₹ 4118 cr as against ₹ 4057 cr during the same period last year. Its EBITDA grew by 5% to ₹ 597 cr (₹ 567 cr), EBIT by 9% to ₹ 456 cr (₹ 418 cr), PBT by 30% to ₹ 111 cr (₹ 85 cr) and PAT by 64% to ₹ 88 cr (₹ 53 cr).

Kolkata, February 14, 2018 – Simplex Infra has announced its Standalone Unaudited Financial Results for the 3^{rd} Quarter and Nine Months ended Dec'17.

During the quarter the Company achieved income from operations of ₹ 1360 cr as against ₹ 1386 cr same quarter last year. Its EBITDA rose by 3% to ₹ 200 crs (₹ 194 crs) , EBIT by 7% to ₹ 155 cr (₹ 145 cr), PBT by 42% to ₹ 40 cr (₹ 28 cr) and PAT by 69% to ₹ 31 cr (₹ 18 cr)

During the Nine months of FY18, the Company's income from operations is ₹4118 cr as against ₹4057 cr during the same period last year. Its EBITDA grew by 5% to ₹597 cr (₹567 cr), EBIT by 9% to ₹456 cr (₹418 cr), PBT by 30% to ₹111 cr (₹85 cr) and PAT by 64% to ₹88 cr (₹53 cr).
