Musk wants longer Twitter trial delay

August 31

ELON MUSK IS planning to seek a delay in the trial over his \$44 billion proposed buyout of Twitter until as late as December, amid new whistle-blower revelations about the company's response to bot accounts, according to people familiar with Musk's strategy.

In a Tuesday court filing, Musk had proposed the October 17 trial be pushed to some time in November, but the people said he is preparing ask Delaware Chancery Court Judge Kathaleen St. J. McCormick for delay until early December. He wants more time so he can properly assess the claims former Twitter computer security head Peiter Zatko made last week in a whistle-blower complaint to regulators and Congress.

Zatko said that he raised concerns about the numbers of robot and spam accounts but was ignored. Twitter is suing Musk to force him to complete the deal, but the billionaire says the company's misleading statements about bot accounts give him a valid reason to cancel his \$54.20-per-share offer.

A December trial would get Musk closer to the February date after Twitter filed the case in July. McCormack fast-tracked the case over his objection.

Musk proposed a November trial as part of his request to

amend his counterclaims, which was filed under seal Tuesday in Delaware Chancery Court. According to the people, Musk wants to add Zatko's allegation that Twitter had "egregious deficiencies" in protecting users' accounts from hackers as further justification of his deci-

sion to nix the deal. He also contends Twitter executives knew about Zatko's claims but didn't disclose them he originally suggested shortly when they agreed to the deal in April, the people said. Twitter also allegedly refused to turn over Zatko's internal files and emails as part of the litigation, saying they weren't relevant.

THE CONVICTION RATE in human trafficking cases across the country continues to be low, according to the latest report of the National Crime Records Bureau (NCRB). While police filed chargesheets in 84.7% of the 2,189 cases registered under the Anti-Human Trafficking Units (AHTUs) across the country in 2021, only 16% of the cases saw convictions.

While the data on convictions was not available for 11 states, as many as eight states and three Union territories saw no convictions at all. The top performer was Jharkhand, which saw convictions in 84.2% of the 92 cases that were registered in 2021.

In 2020, police filed chargesheets in 85.2% of the 1,714 trafficking cases that were registered, but only 10.6% of the total cases saw convictions. Seven states reported no convictions while two reported a conviction rate of less than 2%.

In 2019, a total of 2,260 human trafficking cases were registered, of which police filed chargesheets in 83.7%, while there were convictions in 22%. Four states reported no convictions at all. The states and Union territories which reported zero convictions in 2021 are: Arunachal Pradesh, Assam, Goa. Haryana, Himachal Pradesh, Karnataka, Odisha, Telangana, Delhi, Chandigarh and Jammu and Kashmir. Of these, police had filed final chargesheets in

over 90% of the cases in Himachal Pradesh, Karnataka, Telangana: and in over 80% of the cases in Goa and Haryana.

The highest number of trafficking cases was registered in Telangana (347 cases), Maharashtra (320 cases), and Assam (203 cases).

Over the last three years, Maharashtra, Andhra Pradesh and Telangana have seen the highest number of human trafficking cases, followed by Assam, Jharkhand, Kerala, Odisha and Rajasthan. Barring Telangana, all states saw a dip in cases in 2020, the first year of the pandemic which saw lockdowns.

According to the NCRB data, of the 6,533 victims of human trafficking in the 2,189 cases filed last year under the 768 AHTUs across the country, 4,062 were female. As many as 2,877 victims were minors: 1,570 boys and 1,307 girls.

filed final Police chargesheets in over 90% of the cases in Madhya Pradesh, Himachal Maharashtra, Pradesh, Rajasthan, Tamil Nadu, Karnataka, Chhattisgarh, Andhra Pradesh, Telangana and Uttar Pradesh; and in over 80% of the cases in Punjab, Kerala, Haryana, Goa and Bihar.

"The gap between the chargesheets and the conviction rate shows that the police investigation in these cases was not robust. The lack of evidence is commensurate with the lack of conviction. Often, in order to close a case, police go for the low hanging fruit, apprehending persons who are not directly involved in the trafficking, leading to a large number of acquittals," said criminal lawyer Kaushik Gupta, who deals in human trafficking cases.

This disparity, between the chargesheets filed and convictions obtained, is evident in rape cases as well. In 2021,

police filed chargesheets in 82% of the rape cases that were registered, while only 28.6% of the total cases saw convictions. In 2020, chargesheets were filed in 82.2 per cent of the cases, while convictions were obtained in 39.3%. In 2019, chargesheets were filed in 81.5% of the cases, while convictions were obtained in 27.8%.

"Trafficking cases are complex — they span across districts, states and even international borders in many cases. They are therefore inter-jurisdictional, which makes it difficult for the police to probe these cases, catch offenders and gather evidence. The setting-up of anti-human trafficking units, with dedicated police trained to handle trafficking cases, is a step in the right direction, but we need more AHTUs,"he said.

"Once the new, very comprehensive, trafficking Bill is tabled and passed, many of these issues will be resolved. Also, keep in mind that the data provided by the NCRB is a huge underestimate, as it only includes cases under the AHTUs and not under the local police. In addition, trafficking cases are deemed as such only when there is evidence. In the absence of evidence, they are treated as either kidnapping or missing persons cases,"he said.

According to the NCRB data, therewere 1,05,036 abductions in 2019, 84,805 abductions in 2020, and 1,01,707 abductions in 2021. There were 3,89,844 cases of missing persons, and 77,535 cases of missing children registered in 2021.

India to commission first home built carrier, but short of jets on deck

INDIA WILL FORMALLY commission its first home-built aircraft carrier on Friday, the culmination of 17 years of construction and tests as the country seeks to catch up with regional rival China and its far larger naval fleet. The INS Vikrant however

will not have its own fleet of fighter jets on deck and instead will rely on a few Russiandesigned aircraft borrowed from India's only other carrier, the INS Vikramaditya. France's Dassault and Boe-

ing are locked in a race to provide the Indian government with over two dozen jets earmarked for the Vikrant, a 262 metre-long vessel built at the state-run Cochin Shipyard in southern India.

The Indian Navy and India's defence ministry did not respond to questions from *Reuters*. Designed by the Indian Navy, the carrier is the largest warship to be built in the coun-
